The PRC was established in 1954 by Professor Dan McGill to sponsor nonpartisan research on companysponsored pensions. Dr. McGill, a Wharton Professor of Insurance, served as the Council's first director. Dr. Canby Balderston, Dean of the Wharton School at the time, noted that the Council was formed to study the pension movement, saying:

There has been a tremendous growth in the number and coverage of private pension plans, but there is a deplorable lack of factual information concerning the economic, political and social implications of the movement... [PRC] research will be concentrated in areas not the subject of special investigation by other research organizations.







Advisory Board Members of the Pension Research Council are leaders in the field and include business executives, attorneys, labor experts, consultants, policymakers, and academics, each appointed by the Dean of the Wharton School. The Council's work is supported by annual contributions from Members, publication revenue, and research grants. Additional support is provided by the Boettner Center for Pensions and Retirement Research, and the Ralph H. Blanchard Memorial Endowment established by the Mutual of America Life Insurance Company.




