Rob Bauer is Professor of Finance and holder of the Elverding Chair on Sustainable Business, Culture, and Corporate Regulation at the Maastricht University School of Business and Economics in The Netherlands. He is also Co-Founder and Director of the European Centre for Corporate Engagement at Maastricht University and Executive Director of the International Centre for Pension Management in Toronto. He cofounded GRESB, a real estate sustainability benchmarking company, and Co-Chairs the Global Research Alliance on Sustainable Finance and Investment. Bauer holds a Ph.D. from Maastricht University School of Business and Economics.

Jennifer Bender is a Senior Managing Director at State Street Global Advisors and Director of Research for the Global Equity Beta Solutions team, where she leads research at SSGA in index investing include core beta, smart beta, ESG and thematic investing. Previously, she was Vice President in the Index and Analytics Research teams at MSCI, an economist at DRI, and researcher at State Street Associates and Harvard University. She serves on editorial boards for *The Journal of Portfolio Management* and *The Journal of Systematic Investing*. Bender holds MS and PhD degrees in Economics from Brandeis University.

Julia Coronado is President and Founder of Macro Policy Perspectives. Previously, she was Chief Economist for Graham Capital Management, L.P., and Chief Economist for North America at BNP Paribas. She also served as Senior U.S. Economist at Barclays Capital and as an Economist for the Federal Reserve Board of Governors. Her research focuses on understanding interactions between financial markets and the real economy, forecasting the US economy, and monetary and fiscal policy. She is a member of the Economic Advisory Panel of the Federal Reserve Bank of New York. She earned her Ph.D. in economics from the University of Texas at Austin.

Joel M. Dickson is Vanguard's global head of Advice Methodology where he oversees investment methodology development for Vanguard's advice programs for individual investors. Previously at Vanguard, he served in the Investment Strategy Group, Quantitative Equity Group, and Portfolio Review Department; earlier he was a staff economist at the Federal Reserve Board analyzing trends in the pension and mutual fund sectors. He earned his A.B. from Washington University in St. Louis and the Ph.D. in economics from Stanford University.

Gerben de Zwart is head of Investment Solutions at APG Asset Management in The Netherlands, where he leads the investment specialists team. He directs the Quant Solution & Developer teams in operationalizing advanced analytical information platforms, and he oversees some of APG's data science and model risk management initiatives, including its Sustainable Development Goal's

Initiative and its alpha research with Entis. Previously, he was responsible for APG's €100+ billion systematically managed investment portfolios. He has also worked with ING Investment Management and Robeco. He earned his Master's degree in Technical Mathematics from Delft Technical University and his Ph.D. from the Erasmus University Rotterdam, and he holds the Chartered Financial Analyst designation. He was appointed as a member of the Order of Oranje-Nassau as one of the youngest decorated people in the Netherlands.

Nathan Fabian is the Chair of the European Platform on Sustainable Finance, a public and private sector expert panel to develop sustainable finance policies and tools in Europe, including the EU Taxonomy. Fabian is also Chief Responsible Investment Officer at the United Nations-supported Principles for Responsible Investment (PRI). Previously he served as CEO of the Investor Group on Climate Change Australia/New Zealand; head of ESG Research at Regnan, a provider of ESG research and engagement services; and Corporate Governance Policy Advisor in the Australian Parliament. He is also a founding Partner of Full Corp Partners, a financial services and IT start-up company advisory firm. Fabian earned his M.A. in International Relations from the University of New South Wales and the BBus from the University of Newcastle (Australia). He is also is a Vincent Fairfax Fellow in ethics and leadership.

Michael Garland is Assistant Comptroller for Corporate Governance and Responsible Investment for New York City Comptroller Scott M. Stringer who serves as investment advisor, custodian and a trustee to the New York City Pension Funds with approximately \$240 billion in assets under management and a long history of active ownership on issues of corporate governance and sustainability. Garland and his team develop and implement the Funds' active ownership programs for public equities, including voting proxies at approximately 11,000 portfolio companies around the world; engage portfolio companies on their environmental, social, and governance policies and practices; and advocate for regulatory reforms to protect investors and promote sustainable capital markets. Recent initiatives include spearheading the Boardroom Accountability Project launched which has helped establish proxy access as a fundamental right at hundreds of U.S. companies. Garland also serves on the Council of Institutional Investors' Board of Directors, where he is Public Fund Co-Chair, and the Grant & Eisenhofer ESG Institute Oversight Board. He is also Comptroller Stringer's designated representative to the board of directors of CERES, a non-profit that works with investors, companies, and capital market influencers to take stronger action on the world's biggest sustainability challenges.

Susan N. Gary is Professor Emerita at the University of Oregon School of Law (formerly Orlando J. and Marian H. Hollis Professor). Previously she practiced with Mayer, Brown & Platt in Chicago, and with DeBandt, van Hecke & Lagae in Brussels. Her research areas include fiduciary duties and the prudent investor standard, the regulation of charities, the definition of family for inheritance purposes, and donor-restricted charitable gifts. She is a member of the American Law Institute and an Academic Fellow and former Regent of the American College of Trust and Estate Counsel. She served as a trustee on the University of Oregon's Board of Trustees. She received her B.A. from Yale and her J.D. from Columbia.

Chris Geczy is Academic Director of the Jacobs Levy Equity Management Center for Quantitative Financial Research at the Wharton School, where he is also Academic Director of the Wharton Wealth Management Initiative at Wharton Executive Education. He earned the Best Elective Course Teaching Award in the Wharton Executive MBA Program and the Wharton Teaching Excellence Award, and he created Wharton's first survey course in sustainable/ESG investing. He received his B.A. in economics from the University of Pennsylvania and the Ph.D. in finance and econometrics from the Graduate School of Business at the University of Chicago.

John B. Guerard is a member of the McKinley Capital Management Scientific Advisory Board, and he teaches as a Zoom Affiliate Faculty member in the Computational Financial and Risk Management Program at the University of Washington, in Seattle. Previously he served as Director of Quantitative Research at McKinley Capital Management, and he taught at the McIntire School of Commerce, the University of Virginia, Lehigh University, New York University, Rutgers, and the University of Pennsylvania. While serving as Director of Quantitative Research at Vantage Global Advisors (formerly MPT Associates). He was awarded the first Moskowitz Prize for research in socially responsible investing. He earned his AB in Economics from Duke University and Ph.D. in Finance from the University of Texas, Austin.

Anita Margrethe Halvorsen is the Director of Global Legal Solutions, LLC. Previously, she served as Adjunct Professor at University of Denver and Legal Counsel at the Norwegian Ministry of Climate and Environment; she has also consulted for the WHO. She has researched and published on the Norwegian Government Pension Fund Global (formerly known as the Norwegian Oil Fund). Halvorsen is a member of the International Law Association committee on International Law and Sea Level Rise. She earned her Master's (LLM) and Doctor of The Science of Law (J.S.D.) from Columbia University, and her first law degree was from the University of Oslo, Norway.

P. Brett Hammond is a research leader at the American Funds of the Capital Group; he is also Executive Vice President of the Q Group and member of the Pension Research Council's Advisory Board. Previously he directed research teams at MSCI, and he served as chief investment strategist at TIAA-CREF while working on the creation of target-date funds, inflation-linked bonds, and individual financial advice. He also served on the senior management team at The National Academies, responsible for behavioral and social sciences studies; he also taught at The Wharton School. His research focuses on investing, institutional and individual asset allocation, pensions, higher education, and public policy. He received the bachelor degree in economics and political science from the University of California at Santa Cruz, and a Ph.D. from the Massachusetts Institute of Technology. Brett is currently editor-in-chief of the peer-reviewed *Journal of Retirement*.

Witold J. Henisz is the Deloitte & Touche Professor of Management in Honor of Russell E. Palmer at The Wharton School of The University of Pennsylvania. He is also Director of the Wharton Political Risk Lab and the founder of the Wharton ESG Analytics Lab. His research examines the impact of political hazards as well as environmental, social and governance factors

more broadly on the strategy and valuation of global corporations. This work analyzes best practices in corporate diplomacy to win the hearts and minds of external stakeholders as well as the measurement thereof. Witold has won multiple teaching awards at the graduate and undergraduate levels and he also teaches extensively on the topic of Corporate Diplomacy as well as ESG integration in open enrollment and custom executive education programs. He is also a principal in the consultancy PRIMA LLC whose clients span multinational firms, asset managers, intergovernmental organizations, and non-governmental organizations. He earned his Ph.D. from University of California at Berkeley, his M.A. from Johns Hopkins University, and his B.A. from Stanford University.

Mikael Homanen is a Senior Specialist, Research at Principles for Responsible Investment (PRI), where he leads the development of internal academic research and ESG data integration projects. He is also an Honorary Research Fellow at the Business School (formerly Cass) in London. He was previously a Bradley Fellow at the University of Chicago Booth School of Business, a visiting scholar at the Wharton School, University of Pennsylvania, and visited Singapore Management University. He has also consulted with the World Bank's Development Economics Research Group, Finance and Private Sector Research team. Stéphanie Lachance is Managing Director, Responsible Investment at the Public Sector Pension Investment Board (PSP Investments) where she leads the Responsible Investment group, which plays a key role in the organization's investment strategy to ensure that environmental, social, and governance factors are incorporated in investment decisions and across all asset classes. Her interests include corporate governance, responsible investment, securities law, and regulations, she advised public issuers, stock exchanges, and securities regulators, prior to joining PSP Investments. Raimond Maurer is Professor of Investment, Portfolio Management, and Pension Finance at the Finance Department of the Goethe University Frankfurt. Previously he was in residence at the Wharton School as Visiting Professor, and he serves as Advisory Board member of the Pension Research Council. Concurrently Dr. Mitchell serves as a Research Associate at the NBER; Independent Director on the Wells Fargo Fund Boards; Co-Investigator for the Health and Retirement Study at the University of Michigan; and Executive Board Member for the Michigan Retirement Research Center. She also serves on the Academic Advisory Council for the Consumer Finance Institute at the Philadelphia Federal Reserve; the Advisory Committee of the HEC Montreal Retirement and Savings Institute; and the UNSW Centre for Pensions and Superannuation. She earned her B.A. in Economics from Harvard University, and her M.S. and Ph.D. degrees in Economics from the University of Wisconsin-Madison.

Billy Nauman is a Reporter with the *Financial Times* and producer of Moral Money, the new digital platform and newsletter from the FT featuring news and analysis about the fast-expanding world of socially responsible business, sustainable finance, impact investing, environmental, social and governance trends.
